Certificate of Professional Indemnity and Public Liability Insurance

On behalf of all current DIA members (and only in so far as they individually continue to subscribe their annual membership payment in full) the DIA has corporately arranged the following exclusive insurance cover, for which the required premiums have been paid in full:-

PUBLIC LIABILITY POLICY - Policy Numbers: GBT004878220W/AS100141 and B0334SC3342022372

This policy provides protection for DIA members against claims by third parties for legal liabilities following bodily injury or damage to property while they are carrying out their instructional activities, subject to policy terms and conditions and including a policy excess of £500. This can be in the classroom or vehicle, or on private property, if you are deemed to be responsible.

The sum insured is up to £20,000,000 (twenty million pounds, each and every claim).

PROFESSIONAL INDEMNITY POLICY - Policy Numbers: BP06927-2301 and BP06925-2301

This policy provides protection in the event of a claim being brought against a DIA member for errors or omissions with respect to professional advice, subject to policy terms and conditions including policy excess of £1000. This can be for tuition either in the classroom or whilst on the road training.

Road traffic accidents fall under the coverage of your general motor insurance policy.

The sum insured is up to £5,000,000 (any one claim and in the aggregate including defence costs)

Geographical limits are the United Kingdom of Great Britain & Northern Ireland, Isle of Man and Channel Islands.

The above policies are renewable by the DIA on 26 June 2024.
